Dear Competitors,

We hope your preparations are going well for the upcoming Angus Youth Round Up.

Please read the following biosecurity regulations for AELEC that must be strictly adhered to:

**National Vendor Declarations (NVDs):**

NVDs or eNVDs must accompany each load of cattle so that they can be recorded in the NLIS database. Please ensure this paperwork is completed before or ready upon arrival. Cattle will be scanned on and offsite by a Nutrien representative.

**Cattle Ticks:**

- All horses coming to AELEC originating from Qld in the cattle tick infested zone or a restricted property in the cattle tick free zone MUST be sprayed for ticks by an accredited tick sprayer or vet (certification to be shown) and must have a Record of Movement.
- If you are coming from a Qld cattle tick free area directly to AELEC (not unloading through an infested region) you do not need to spray.

**Imported Red Fire Ants:**

NSW DPI have stopped all movement of fodder from infested ant areas unless a Plant Health Certificate is provided (see the current Emergency Order: [Biosecurity \(Fire Ant\) Emergency Order \(No. 16\) 2025](#). As such, any hay/chaff from Fire Ant infested areas will not be allowed to enter the grounds. If carrier material (including hay, chaff and silage) has travelled through an infested area uncovered, it will not be allowed entry into AELEC. It must be wrapped in plastic and left outside of AELEC for the competitor to collect on their departure.

**Fire Ant Transit Clause:** Certain fire ant carriers that come from outside the fire ant infested areas can transit through the fire ant infested areas without treatment, certification or Record of Movement declarations if they are kept in preventative conditions while in transit. Preventative conditions are defined in Clause 10 of the Order and include keeping the carrier material completely covered or enclosed, and high enough so that none of it is touching the ground.

For biosecurity purposes, AELEC Conditions of Entry recommend no fodder be brought in from interstate and should be purchased from a supplier within 150km of the AELEC. Fodder can be ordered through our local supplier – Furney' Stock feeds (02) 6762 1363 who will deliver to your stable/campsite.

The above are DPI regulations and AELEC must sight the appropriate paperwork before your entry into the venue. Please have your paperwork in order upon arrival. If you do not have the correct paperwork, entry to be AELEC may be denied. NSW DPI have the right to conduct random inspections on competitors during their stay at AELEC and fines may apply.

**Parthenium weed:**

Parthenium weed (*Parthenium hysterophorus*) is widespread in central Qld and is a prohibited, high-risk weed in NSW. Help prevent Parthenium weed establishing at AELEC by cleaning mud and seeds from machinery and vehicles before your arrival and alerting AELEC management if you see a suspicious plant on site.
